An important federal regulation called the "Red Flag Rule" with mandatory compliance on November 1, 2008, will be one of the agenda items. It affects every business that sells equipment via finance contracts, even if the contract is through an outside vendor. We will explain how businesses must protect the private information of their customers from identity theft, and provide a free program for compliance.

Other topics will include: Trucking regulations and drug screening, fast tractors (OH), OSHA hazard assessment and PPE, SPCC, labor rates, manufacturer relations survey, MBT impact on dealers (MI); workforce development, paid sick leave initiative (OH), compensation survey, cost of doing business survey, flat rate guides, workers' comp changes (OH), how to use the Association's Fastfacts database, and more....
